Goal 3 - By- Laws revisions Governing Structure and Quorum definition for the Annual Meeting

- Karen and Bobbi are working on clarifying the definition of quorum for the Annual meeting as historically the meeting used to be in person where you could clearly identify who is an alum vs not an alum
- Karen and Bobbi are thinking about the organization structure and proposing going back to the President and Vice-President structure.
- They think the co-president model is not good for succession planning. And it has been difficult for both of them to operate as co-presidents
- Lynne provided context on co-presidents structure that it was established because both Theresa and Lynne were going to focus on separate initiatives like working with the school vs. working on AAEB's initiatives specifically
- Elaine chimed in saying that the co-president model does not exist in corporations. She thinks the President should delegate responsibility and co-president acts as a proxy to the President
- Bobbi mentioned that for the purpose of succession planning, it was beneficial to have President and Vice-President model
- Elaine added that Kelly's position can have a co-director model or she should have a bigger committee to help her with execution of responsibilities
- Bobbi announced that she will be stepping down as a co-president as soon as we find a Vice-President to work with Karen
